#### **President -** The duties and authority of the President shall be as follows:

- To direct and supervise the affairs of this organization
- To delegate the duties and supervisory responsibilities of the person's officers and directors
- To preside at all meetings of the general membership
- To appoint from the membership such special and permanent committees as shall be necessary for the proper administration of the affairs of this organization
- To be ex-officio member of all committees except the nominating committee
- To collect at the last meeting of the fiscal year all records of the organization and to deliver them to the new president for distribution at the following meeting
- To exercise all recognized powers of the President's office unless expressly denied by these by-laws
- To give or cause to be given written notice of all general membership meetings of this organization
- To maintain a file of all incoming and outgoing correspondence at regular meetings
- To appoint the Parliamentarian

#### **Vice-president -** The duties and authority of the Vice-President(s) shall be as follows:

- To be vested with all the powers and to perform all the duties of the President in the President's
  absence. Also, to fulfill the unexpired term of the Presidency in case of resignation or permanent
  disability of the President, and then shall appoint a successor to the position of Vice-President with
  approval of the Board of Directors
- To perform such additional duties as may from time to time be authorized by the President and Board of Directors
- To supervise the activities of and be responsible for the Standing Committee Chairmen

#### **Secretary -** The duties of the Secretary shall be as follows:

- To make and preserve the minutes and records of all meetings of this organization and of the Board of Directors
- To maintain a roll of active members certified by the Treasurer
- To perform such other duties as may be assigned by the President and the Board of Directors

#### Treasurer - The duties of the Treasurer shall be as follows:

- To maintain an accurate record of all finances of this organization and submit a monthly Treasurer's Report in triplicate (one copy for the President, one copy for the Secretary, and one copy for the Treasurer's file)
- To deposit all funds of this organization into a bank selected by the membership. All monies in the hands of any member due this organization shall be delivered to the Treasurer for such deposit
- To make all disbursements of this organization by check only, which shall bear both the Treasurer's signature and that of the President or the Vice-President. TheTreasurer shall not make any disbursement except upon receipt of an authorized bill
- To maintain a file of bank statements and appropriate paperwork of each paid bill
- To maintain a record of the status of each member's dues and to certify to the Secretary, from time to time as may be necessary, members who are in good standing
- To give notice to each member of the date dues are payable and to give notice to delinquent members in advance of their anniversary date as specified in Article II, Section 3, of these by-laws
- To perform such additional duties as may be assigned to the Treasurer by the President and the Board of Directors
