## To Garage Sale or Not to Garage Sale, That is the Question ....

At the last meeting, members did not really express a desire one way or the other to hold a KWOT garage sale. We need to determine if there is a need or desire to hold a garage sale. Please think about this and determine if you will put items in a garage sale to be held either late in July or early to mid-August. You can either email Marilyn at mgibbons@truman.edu or report of the June 28 meeting if you want to have a garage sale or not. Please commit one way or the other so that we can set an official date or skip the idea.

After reviewing the notes from last year's sale, we made $\$ 485$ (includes donations of $\$ 120$ ) with 30 pies, banana bread, pumpkin bread, cupcakes, angel food cake, brownies, monster cookies, and sugar cookies. The kinds of pies we sold were: apple, blueberry, strawberry rhubarb, gooseberry, peach, cherry, "red, white, \& blue", rhubarb, raisin cream, pecan, no sugar added cherry, bumbleberry, blackberry, pumpkin. Suggestions after the sale were:

- More gooseberry and blackberry pies
- Only one batch of brownies (individually wrapped) - had some left over
- Cookies didn't sell well - had several left over

I will have a sign-up sheet at the June meeting for baked goods as well as other supplies we'll need that day. Also, l'll have a sign-up sheet for times to help at the booth. Last year the prices were:

Pies - \$8
Brownies, cupcakes, \& cookies - \$0.50
Breads - \$1.50
Angel Food cakes - \$4 for a whole cake and \$0.50 for small ones
We will discuss prices at the meeting. If you are unable to attend the meeting, but are willing to help provide baked good and/or assist with the staffing of the booth, please let me know.
